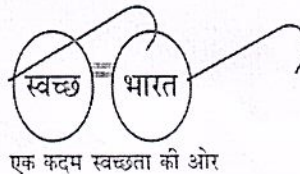

NOTIFICATION

In exercise of the power conferred by sub-section (3) and (4) of section 17 of the Banaras Hindu University Act 1915 (16 of 1915), the Executive Council, with the approval of the Visitor, hereby makes the following amendments further to amend the Banaras Hindu University Statutes, 1915 namely:-

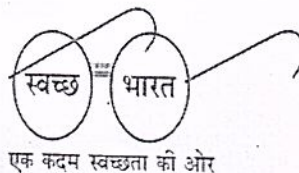

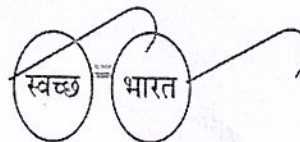
