The National Institutional Ranking Framework (NIRF) Member Secretary has issued the following advisory for strict compliance by all concerned while issuing advertisements in the News Paper or uploading information on the website:

1. Provide appropriate category and exact rank in that category. Do not bifurcate ranks state wise or district level. The banner to displaying ranks is provided on the NIRF website as well
2. There are no such categories as private institutions, government institutions, self-financing, not for profit etc. Do not create additional categories or disciplines and rank your institutions in these self-made categories.
3. Institutions falling under rank band should highlight only the rank band in which they fall. Please do not try to create ranks within rank bands.

National Institutional Ranking Framework (NIRF) Member Secretary has further informed that if any institution is found in non-compliance of the above advisory it will be debarred from further ranking exercise.

The Vice-Chancellor has considered the above advisory and approved the same for implementation in the University. All are, therefore, directed to ensure strict compliance of the aforesaid NIRF guidelines.
