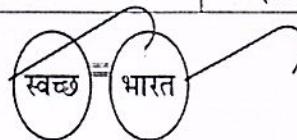
NOTIFICATION

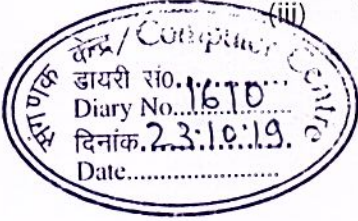
